**ORDER**

**THIS MOTION**, made by KPMG Inc. in its capacity as the Court-appointed Receiver of Genfast Manufacturing Company (“the Receiver”), was heard this day at 330 University Avenue, Toronto, Ontario.

**UPON READING** the Eleventh Report of the Receiver dated July 17, 2008 (the “Eleventh Report”) and upon hearing the submissions of counsel for the Receiver and the Pension Plan Administrator;

1. **THIS COURT ORDERS AND DECLARES** that the time for service and filing of the Notice of Motion and the materials therein be and is hereby abridged, if necessary, and that all persons requiring notice of this Motion have been duly served with notice thereof, and that the service including the form, manner and time thereof be and is hereby validated, and that further service thereof be and is hereby dispensed with.

2. **THIS COURT ORDERS** that all capitalized terms not otherwise defined herein have the same meaning as in the Eleventh Report.
3. **THIS COURT ORDERS** that the Disputed Pension Claims Settlement, as described in the Eleventh Report, and as set out at Schedule "GG" to the Eleventh Report, is hereby approved.
4. **THIS COURT ORDERS AND DECLARES** that the Disputed Pension Claims are hereby dismissed.
5. **THIS COURT ORDERS** that the Receiver is hereby authorized and directed to pay, from the Disputed Pension Claims Reserve, the amount of CDN \$87,500.00 to the Pension Plan Administrator with respect to the Disputed Pension Claims Settlement as described in the Eleventh Report and Schedule "GG" to the Eleventh Report.
6. **THIS COURT ORDERS** that the Receiver is hereby authorized and directed to pay, from the Disputed Pension Claims Reserve, the amount of CDN \$79,229.00 with respect to the D&O Vacation Pay Claims, to those former Genfast employees who are entitled to receive such payments.
