

Labor – Waiver of Financial Penalties for the Renewal of Foreigner Work Permits for the Year 2020 until further notice

Ministry of Labor and Vocational Training (MLVT) – Instruction No. 044/20 dated 08 April 2020 on the Waiver of Financial Penalties for the Renewal of Foreigner Work Permits for the Year 2020 until further notice

Generally, all foreign employees who are working in Cambodia must renew their work permits no later than 31 March of each year. The deadline for the renewal of work permits for foreign employees for the year 2020 was on 31 March 2020. Failure to renew the work permits within the deadline will be subject to financial penalties (or fines) imposed by the MLVT.

Due to the global Covid19 pandemic, the MLVT has issued Instruction No. 044/20 dated 8 April 2020 to waive the financial penalties (fines) for those foreign employees who already obtained or hold their work permits for the year 2019 until further notice.
