- The proof of claim must be signed by the individual completing the form.
- □ The signature of the claimant must be witnessed.
- A complete address must be provided including the postal code where all notices and correspondence are to be forwarded.
- □ The amount on the statement of account must agree with the amount claimed on the proof of claim.

# PARAGRAPH 1 OF THE PROOF OF CLAIM

- □ The creditor must state the full and complete legal name of the Company or the claimant.
- If the individual completing the proof of claim is not the creditor himself, he must state his position or title.
- The creditor must identify which of the Debtors it is filing a claim against. The creditor may refer to the creditor listings of each of the Debtors (included in the claims package), as applicable.

# PARAGRAPH 3 OF THE PROOF OF CLAIM

A detailed statement of account must be attached to the proof of claim and must include the date, the invoice number and the dollar amount of all invoices or charges, together with the dates, the number and the amount of all credits or payments.
