

Eligibility criteria

competition, you must:

- conduct all pitches in English;
- be a registered company in Estonia;
- have raised at least US \$500,000 in equity OR generate a revenue between US \$1 million and \$15 million;
- be available to pitch at the country final event in Tallinn in May 2024 on Latitude59 stage
- have been actively operating for 5 years or less (in the current form);
- not be majority owned by a large corporate;
- if selected as a finalist, be available to pitch at the global final in Lisbon,
 Portugal in November 2024 on Web Summit
